

- 2. Included is the Standing Orders Transition Plan by Te Whare Ariki o Runga Wakaminenga o Nga Hapu o Nu Tireni Sovereign Party to He Wakaputanga o Te Rangatiratanga o Nu Tireni 1835 me Te Tiriti o Waitangi 1840.
- 3. Te Whare Ariki o Runga Tino Rangatira o Te Wakaminenga request a meeting at Waitangi with Prime Minister Jacinda Ardern from the 3-6 February, 2018 at a time agreed to whakawhiti korero regarding the Standing Orders.
